I hereby agree to the following:

I am participating in an Integral Somatic Psychology™ Training (the “Training”) of my own will and volition and voluntarily agree to all the terms and conditions of this Informed Consent and Release Agreement (“Agreement”). I am not under the influence of alcohol or drugs at this time and am sufficiently qualified, trained and capable to participate in the Training and all Released Activities.

I understand and agree that I will be solely and exclusively liable for all my acts and omissions at all sessions, meetings, and consultations related to any Trainings, including, but not limited to, at a Training event, through my private practice, and at an unaffiliated location.

If applicable, I will at all times be a fully paid and up-to-date member of a professional association maintaining an industry-standard code of ethics, AND/OR I will at all times maintain a fully paid and up-to-date professional license with an applicable regulatory agency.

No grievance, complaint, or action has been brought or filed against me before any licensing, regulating, associative, or legal body for any violation or misconduct of any kind.

I will at all times maintain and fully fund comprehensive professional liability or malpractice insurance with appropriate coverage amounts in accordance with the regulations of the country/region where I practice sessions and/or consults.

I acknowledge and agree that the Training is the exclusive intellectual property of Integral Somatic Psychology LLC (“ISP”) (the “Intellectual Property”). I further understand that ISP is the exclusive owner or licensee of all materials utilized in the Training including, but not limited to, all printed, audio, video, digital, online, and other materials (“Materials”). The Materials also include all duplicates, reproductions, and derivatives of the Materials, as well as any materials, research, books, articles, and other works of authorship, as well as products or services, created by ISP and related to the Training (collectively, “Materials”). ISP retains all rights in and to all Intellectual Property utilized or referenced in the Training and the Materials including, but not limited to, the copyrights in the Materials and all associated trademarks. No Materials or any portion thereof are sold or otherwise transferred and ISP does not sell any title, ownership right, or interest in or to any of the Materials. I will not acquire any right of ownership, in whole or in part, in and to any of the Intellectual Property. reproduce, distribute, publish, or discuss any of the confidential information contained in or related to the Training.

ISP shall not be liable or responsible for any unauthorized recording of the Training. I also agree that ISP shall have no liability or responsibility for the use or exploitation of any unauthorized recordings.

I understand that if at any time the ISP approves the recording of a Training, I hereby grant to ISP the right and permission to film, photograph, videotape and/or record me (including my image, picture, likeness and/or voice) and to use the resulting film, photographs, videotapes, digital imagery and/or recordings (collectively, the "Footage"), as edited or altered by ISP in order to create marketing and promotional materials, training materials and reports, or other work product created by or for the benefit of ISP ("Work Product"). ISP has no liability or responsibility for my participation or involvement in any demonstration and I accept that any result or no result may occur due to my participation or involvement.

I understand that the primary purpose for participating and receiving the Training is educational — to offer experiential learning of how Integral Somatic Psychology™ principles are applied in practice so as to support students in their professional training and development.

I will at all times indemnify and hold harmless the Institute, its officers, directors, agents, successors and assigns, from and against any and all claims, actions, damages, costs and expenses (including reasonable attorney fees) related to my acts or omissions in providing services related to any Training.

I understand and agree that I will be solely and exclusively liable for all my acts and omissions at all sessions, meetings, and consultations related to any Trainings, including, but not limited to, at a Training event, through my private practice, and at unaffiliated locations.

In the event that ISP or its authorized representatives or agents or the Training coordinator or faculty member requests that I discontinue my participation and involvement with the Training, I will immediately leave the Training and the premises upon which the Training is being held. If I withdraw from the Training, the ISP refund policy applies.

I understand that my participation in or involvement with the Training (“Released Activities”) may present a health risk to me and/or, if I am pregnant or may be pregnant, to my unborn child. Illness, stress, and other periods of significant personal difficulty can present a health risk. If I may suffer from any health risk or be pregnant and elect to proceed with the Training I do so at my own risk. I accept full liability for my participation and involvement with the Training. If I withdraw from the Training due to any health risk or pregnancy, ISP refund policy applies. This Agreement is the only agreement between me and ISP regarding my participation in the Training, supersedes any other similar agreement, and cannot be modified except in writing by ISP signed by the parties electronically or otherwise. This Agreement will be binding upon me and my heirs, executors, administrators, and legal representatives. I acknowledge that I have carefully read this Agreement, understand its contents, and understands that **this Agreement includes an assumption of risk and release of the Released Parties’ negligence and a release of their liability.** Participant acknowledges that ISP is materially relying on this waiver in allowing me to engage in the Released Activities.

I hereby agree that any and all claims, disputes, demands, or actions or any kind whatsoever arising from or in connection with this Agreement and/or the Released Activities shall be submitted to binding arbitration in Los Angeles County, California, USA in accordance with the Arbitration Procedures of the American Arbitration Association. I further agree that in the event that any claim, suit, dispute, demand, or action is filed in a location other than Los Angeles County, California, it shall be moved to Los Angeles County, California at the option of the Released Parties. I further agree that this Agreement shall be interpreted and construed under the laws of California regardless of any principles of conflicts of law to the contrary.

These policies, procedures, and guidelines are subject to change without notice to me and will be updated on the website.
